BY THE COMMISSION:

On or about December 5, 2012, the City of Lincoln filed a request to use set aside funding to upgrade existing Phase II 911 equipment and software and maintenance at a total cost of \$36,743.00. Staff requested additional clarification regarding the request. Based upon the response, the City amended the total cost to \$33,323.75. This amount would include \$32,184.00 toward equipment and software and an additional \$1139.75 for one year of maintenance and support. The City of Lincoln is requesting that it be permitted to use its set aside funding in the amount of \$24,179.71, representing 72.56% of the total costs based upon wireless call volumes.

OPINION AND FINDINGS

The Nebraska Public Service Commission (Commission) adopted the permanent cost model to administer funding for public safety answering points for the implementation and provision of Enhanced Wireless 911 service under Docket No. 911-019/PI-118.

the request for funding upon and supporting documentation, the Commission is of the opinion and finds that a portion of the costs requested are eligible under Neb. Rev. Stat. § 86-465 as costs have been incurred or will be incurred for the installation, maintenance or operation telecommunications equipment and telecommunications required for the provision of enhanced wireless 911 service.

Pursuant to the permanent funding mechanism, PSAPs are permitted to retain up to seventy-five percent (75%) of the amount allocated to that PSAP for the future purchase of equipment and software.

Based upon the above, the Commission finds that funding request for the City of Lincoln should be approved in the amount of \$24,179.71, representing 72.56% of the total costs based upon wireless call volumes.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that the request to use set aside funds filed by the City of Lincoln is hereby approved as set forth herein in the amount of \$24,179.71, representing 72.56% of the total costs based upon wireless call volumes which includes costs of equipment and software and one year of maintenance and support.
