O P I N I O N A N D F I N D I N G S

On or about March 30, 2010, the Nebraska Public Service Commission (Commission) opened the above-mentioned docket, on its own motion, seeking to administer funding for public safety answering points for the implementation and provision of Enhanced Wireless 911 service pursuant to the permanent funding mechanism approved under Docket No. 911-019/PI-118.

On April 19, 2010, Burt County filed its application for funding with the Commission pursuant to Docket No. 911-019/PI-118. An order was entered on June 29, 2010, approving funding. However, the order failed to account for prior commitments. Therefore, the Commission finds that the order should be amended to deduct \$2,750.00 from the allocation for previously approved commitments. The following is an amended summary of the funding that is approved and supersedes the June 29, 2010 order.

Burt County, which services the area of Burt County, is eligible for funding in the amount of \$29,073.60 for the 2010-11 funding year. Burt County has indicated that it anticipates using the funding provided for the following purposes: support contracts for 911 hardware and software, support contracts for GIS software support and map updates, other equipment, software, training and services to assist in providing wireless 911 service, and plans to set aside the remainder of its funding for future equipment and software upgrades and purchases.

Prior funding commitments in the amount of \$2,750.00 were previously approved and must be deducted from the allocation based upon funding approved in this docket.

Based upon the above, the Commission finds that funding request for Burt County in the amount of \$26,323.60 should be approved consistent with the allocation determined in Docket 911-019/PI-118.

Pursuant to Docket 911-019/PI-118, Burt County is required to submit documentation to justify expenditures, including an accounting of funds set aside for future equipment and software purchases, and update contact and other information no later than October 15 following the close of the funding year. If the Commission determines that any funds were not used appropriately, funding for the following funding year will be adjusted to recoup any necessary funds. All PSAPs are subject to audit.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that the order entered on June 29, 2010 is amended and funding for Burt County is hereby approved as set forth herein in the amount of \$26,323.60.

IT IS FURTHER ORDERED that Burt County submit required documentation to justify all expenditures with approved funds no later than October 15 following the close of the funding year consistent with the terms of the order approving the permanent funding mechanism and process in Docket 911-019/PI-118 entered on February 23, 2010.
