BY THE COMMISSION:

On or about October 10, 2014, Burt County filed a request for funding to use its wireless enhanced 911 set aside funds for the costs of an upgrade to 911 equipment in the amount of **\$104,452.02**. The total cost of the equipment and software contracts is **\$75,761.86**. The total cost of the maintenance contract requested is **\$28,690.16**. The PSAP's filed wireless call volume is **85%** of total call volume.

The Wireless Enhanced 911 Advisory Board considered the request at its October 20, 2014 meeting and recommended the request be approved.

O P I N I O N A N D F I N D I N G S

The Nebraska Public Service Commission (Commission) adopted the permanent cost model to administer funding for public safety answering points for the implementation and provision of Enhanced Wireless 911 service under Docket No. 911-019/PI-118.

The Commission previously stated PSAPs may set aside up to seventy-five percent (75%) of their annual allocation for future equipment and software purchases and upgrades.¹ PSAPs may utilize these funds solely for upgrades and replacement of PSAP equipment and software up to their wireless/wireline ratio. Prior to expending these funds, PSAPs must submit an application to the Commission for approval.

Costs for maintenance agreements are not an eligible use of the set aside funds. Burt County may use their 2014-2015 annual

allocation, subject to the wireless/wireline ratio, to pay the cost of such contracts. Therefore the request to spend set aside funds in the amount of \$28,690.16 for maintenance is denied.

Based upon the above, the Commission finds that funding request for Burt County should be approved in the amount of **\$64,397.58**.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that the request to use set aside funds for Burt County is hereby approved, as set forth herein in the amount of **\$64,397.58**.






