BY THE COMMISSION:

The Nebraska Public Service Commission opened the present docket on its own motion, seeking to administer funding for public safety answering points for the implementation and provision of Enhanced Wireless 911 service for Washington County.

On or about October 17, 2012, Washington County filed a request for funding seeking \$29,984.00 for the development of an address point layer for its GIS data. The request was unclear as to whether Washington County is asking the Commission to expand eligible expenses for funding to include this expense; whether the county intends to use funds set aside for future equipment and software purchases; or whether it is requesting that the Commission pay this expense outside of the E911-SAM process.

The Commission finds that this matter should be set for hearing on **December 5, 2012 at 10:00 a.m.** in the Commission Hearing Room, 300 The Atrium, 1200 N Street, Lincoln. A similar request was filed by Douglas County. Therefore the Commission finds that the hearing shall be held in conjunction with the hearing on Douglas County's request.
