O P I N I O N A N D F I N D I N G S

On or about March 30, 2010, the Nebraska Public Service Commission (Commission) opened the above-mentioned docket, on its own motion, seeking to administer funding for public safety answering points for the implementation and provision of Enhanced Wireless 911 service pursuant to the permanent funding mechanism approved under Docket No. 911-019/PI-118.

On March 18, 2011, Furnas County filed its application for funding with the Commission pursuant to Docket No. 911-019/PI-118.

Furnas County, which provides services for Furnas County, is eligible for funding in the amount of \$27,590.28 for the 2011-2012 funding year. Furnas County has indicated that it anticipates using the funding provided for the following purposes: support software, technical support of 911 equipment, support contracts for GIS software updates, future purchases of 911 hardware and software, telephone equipment, software, training or services to assist in operation of E-911, and plans to set aside about 70-75% of its funding for future equipment and software upgrades and purchases.

Prior funding commitments in the amount of \$1,516.00 were previously approved and must be deducted from the allocation.

Based upon the above, the Commission finds that the funding request for Furnas County in the amount of \$26,074.28, should be approved consistent with the allocation determined in Docket 911-019/PI-118.

Pursuant to Docket 911-019/PI-118, Furnas County is required to submit documentation to justify expenditures, including an accounting of funds set aside for future equipment and software purchases, and update contact and other information no later than October 15 following the close of the funding year. If the


