O P I N I O N A N D F I N D I N G S

On or about March 30, 2010, the Nebraska Public Service Commission (Commission) opened the above-mentioned docket, on its own motion, seeking to administer funding for public safety answering points for the implementation and provision of Enhanced Wireless 911 service pursuant to the permanent funding mechanism approved under Docket No. 911-019/PI-118.

On March 6, 2014, Cedar County filed its application for funding with the Commission pursuant to Docket No. 911-019/PI-118. Cedar County serves Cedar County and portions of Wayne and Pierce Counties. Cedar County is eligible for funding in the amount of up to \$46,875.60 for the 2014-15 funding year.

Cedar County has indicated that it anticipates using the funding provided for 911 costs related to equipment maintenance, GIS, telephone charges (up to the wireless/wireline ratio), repayment of county inheritance fund used for purchase of 911 CPE, and plans to set aside \$9,000 of its funding for future equipment and software upgrades and purchase.

No prior funding commitments exist.

Based upon the above, the Commission finds that the funding request for Cedar County in the amount of up to \$46,875.60, should be approved consistent with the allocation determined in Docket 911-019/PI-118 paid in monthly installments of \$4,261.42 over eleven months.

Pursuant to Docket 911-019/PI-118, Cedar County is required to submit documentation to justify expenditures, including an accounting of funds set aside for future equipment and software purchases, and update contact and other information no later than

October 15, following the close of the funding year. If the Commission determines that any funds were not used appropriately, funding for the following funding year will be adjusted to recoup any necessary funds. All PSAPs are subject to audit.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that the funding request for Cedar County is hereby approved as set forth herein in the amount of up to \$46,875.60.

IT IS FURTHER ORDERED that Cedar County submit required documentation to justify all expenditures with approved funds no later than October 15, following the close of the funding year consistent with the terms of the order approving the permanent funding mechanism and process in Docket 911-019/PI-118 entered on February 23, 2010.
