BY THE COMMISSION:

On or about April 3, 2017, Cedar County filed a request to use set-aside funds to purchase upgraded Motorola Solutions customer premise equipment (CPE), Equature call logging recorder equipment and five (5) years of maintenance at a total cost of \$85,969.35. The Wireless Enhanced 911 Advisory Board considered the request at its May 8, 2017 meeting and recommended the request be approved.

On or about May 17, 2017, Cedar County filed a revised request for funding with respect to the same equipment, reflecting revised pricing from the vendor, and because multi-year maintenance agreements may not be paid in advance with set-aside funds. Pursuant to the revised funding request, the total cost of the equipment proposed to be purchased by Cedar County is \$48,622.17

The equipment costs are shared costs subject to the wireless/wireline ratio. The wireless ratio for the Cedar County for the 2016-2017 funding year is 69% wireless. Therefore, Cedar County is requesting approval to use funding in the amount of \$33,549.30, representing 69% of the total equipment costs.

OPINION AND FINDINGS

The Nebraska Public Service Commission (Commission) adopted the permanent cost model to administer funding for public safety answering points for the implementation and provision of Enhanced Wireless 911 service under Docket No. 911-019/PI-118.

Based upon the request for funding, supporting documentation, and in consideration of the recommendation of the Advisory Board, the Commission is of the opinion and finds that the costs requested are eligible under NEB. REV. STAT. § 86-465 as costs have been incurred or will be incurred for the purchase, installation,

maintenance or operation of telecommunications equipment and telecommunications services required for the provision of enhanced wireless 911 service.

Based upon the above, the Commission finds that use of set-aside funding by Cedar County should be approved in an amount of up to \$33,549.30.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that the Cedar County request to use set-aside funds for the purchase of CPE and logging recorder equipment is hereby approved, as set forth herein in the amount of up to \$33,549.30.
