OPINION AND FINDINGS

On or about March 30, 2010, the Nebraska Public Service Commission (Commission) opened the above-mentioned docket, on its own motion, seeking to administer funding for public safety answering points for the implementation and provision of Enhanced Wireless 911 service pursuant to the permanent funding mechanism approved under Docket No. 911-019/PI-118.

On April 17, 2013, Dundy County filed its application for funding with the Commission pursuant to Docket No. 911-019/PI-118. Applications for funding were due to the Commission on or before April 15. Per the Commission's policy the late filing of an application will result in a deduction of one month's allocation of funding. Such a reduction is necessary as a matter of fairness those PSAPs who filed applications in a timely manner.

Dundy County, which serves Dundy County, is eligible for funding in the amount of up to \$41,909.35 for the 2013-14 funding year. Dundy County has indicated that it anticipates using the funding provided for costs of 911 hardware and software maintenance, GIS maintenance, LEC costs and training. Dundy County plans to set aside any remainder of its funding for future equipment and software upgrades and purchases. Prior funding commitments exist in the amount of \$3,717 and must be deducted from the allocation. Also, a deduction in the amount of \$3,809.94 must be made due to the late filing of the application. The monthly payments shall be recalculated based upon the reduced annual allocation.

Based upon the above, the Commission finds that the funding request for Dundy County in the amount of up to \$34,382.41 should be approved consistent with the allocation determined in Docket 911-019/PI-118 paid in monthly installments of \$3,125.67 over eleven months.

Pursuant to Docket 911-019/PI-118, Dundy County is required to submit documentation to justify expenditures, including an accounting of funds set aside for future equipment and software purchases, and update contact and other information no later than October 15 following the close of the funding year. If the Commission determines that any funds were not used appropriately, funding for the following funding year will be adjusted to recoup any necessary funds. All PSAPs are subject to audit.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that the funding request for Dundy County is hereby approved as set forth herein in the amount of up to \$34,382.41.

IT IS FURTHER ORDERED that Dundy County submit required documentation to justify all expenditures with approved funds no later than October 15 following the close of the funding year consistent with the terms of the order approving the permanent funding mechanism and process in Docket 911-019/PI-118 entered on February 23, 2010.
