# OPINION AND FINDINGS

On or about March 30, 2010, the Nebraska Public Service Commission (Commission) opened the above-mentioned docket, on its own motion, seeking to administer funding for public safety answering points for the implementation and provision of Enhanced Wireless 911 service pursuant to the permanent funding mechanism approved under Docket No. 911-019/PI-118.

On April 11, 2013, the City of Norfolk (Norfolk) filed its application for funding with the Commission pursuant to Docket No. 911-019/PI-118. Norfolk serves the city of Norfolk and portions of Madison, Pierce, Wayne and Stanton counties. Norfolk is eligible for funding in the amount of up to \$91,730.28 for the 2013-14 funding year.

Norfolk has indicated that it anticipates using the funding provided for costs related to maintenance of 911, CAD, GIS and hardware and software, and plans to set aside up to 62% of its funding for future equipment and software upgrades and purchases.

No prior funding commitments exist.

Based upon the above, the Commission finds that the funding request for Norfolk in the amount of up to \$91,730.28, should be approved consistent with the allocation determined in Docket 911-019/PI-118 paid in monthly installments of \$8,339.12 over eleven months.

Pursuant to Docket 911-019/PI-118, Norfolk is required to submit documentation to justify expenditures, including an accounting of funds set aside for future equipment and software purchases, and update contact and other information no later than October 15 following the close of the funding year. If the Commission determines that any funds were not used appropriately,

funding for the following funding year will be adjusted to recoup any necessary funds. All PSAPs are subject to audit.

## ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that the funding request for Norfolk is hereby approved as set forth herein in the amount of up to \$91,730.28.
