O P I N I O N     A N D     F I N D I N G S

On or about March 30, 2010, the Nebraska Public Service Commission (Commission) opened the above-mentioned docket, on its own motion, seeking to administer funding for public safety answering points for the implementation and provision of Enhanced Wireless 911 service pursuant to the permanent funding mechanism approved under Docket No. 911-019/PI-118.

On April 15, 2013, Colfax County filed its application for funding with the Commission pursuant to Docket No. 911-019/PI-118. Colfax County serves Colfax County. Colfax County is eligible for funding in the amount of up to \$52,339.96 for the 2013-14 funding year.

Colfax County has indicated that it anticipates using the funding provided for costs related to 911 trunking, equipment repair and maintenance, and GIS maintenance and software support, and plans to set aside any remainder of its funding for future equipment and software upgrades and purchases.

Prior funding commitments in the amount of \$3,184 were previously approved and must be deducted from the allocation.

Based upon the above, the Commission finds that the funding request for Colfax County in the amount of up to \$49,155.96, should be approved consistent with the allocation determined in Docket 911-019/PI-118 paid in monthly installments of \$4,468.72 over eleven months.

Pursuant to Docket 911-019/PI-118, Colfax County is required to submit documentation to justify expenditures, including an accounting of funds set aside for future equipment and software purchases, and update contact and other information no later than October 15 following the close of the funding year. If the
