OPINION AND FINDINGS

On or about March 30, 2010, the Nebraska Public Service Commission (Commission) opened the above-mentioned docket, on its own motion, seeking to administer funding for public safety answering points for the implementation and provision of Enhanced Wireless 911 service pursuant to the permanent funding mechanism.¹

US Cellular Corporation (US Cellular) was eligible to receive an allocated amount of up to \$509,175.00 for the 2011-12 funding year and requested funding based on estimated costs in the amount of \$152,292.00. The Commission approved this request for funding on June 28, 2011. That order indicated US Cellular should request increases to this amount should they find during the funding year eligible costs were higher than its estimate, not to exceed the allocated amount.

Upon review, US Cellular found it incurred costs of \$201,811.65. As a result, US Cellular is requesting an adjusted payment of **\$49,519.65** for the 2011-2012 funding year.

For the 2012-2013 funding year, US Cellular was eligible to receive an allocated amount of up to \$249,142.48 and requested funding based on estimated costs in the amount of \$146,692.00. Upon review, US Cellular found it incurred costs of \$151,827.00.

As a result, US Cellular is requesting an adjusted payment of \$5,135.00 for the 2012-2013 funding year.

Based upon the above, the Commission finds that the funding request for US Cellular should be adjusted in the amount of \$54,654.65.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that the funding request for US Cellular is hereby amended in the amount of \$54,654.65.
