O P I N I O N A N D F I N D I N G S

On or about March 30, 2010, the Nebraska Public Service Commission (Commission) opened the above-captioned docket, on its own motion, seeking to administer funding for wireless service providers for the implementation and provision of Enhanced Wireless 911 service pursuant to the permanent funding mechanism approved under Docket No. 911-019/PI-118.

On April 15, 2016, Pinpoint Wireless, d/b/a BLAZE Wireless (Pinpoint) filed an application for funding pursuant to Docket No. 911-019/PI-118. Pursuant to the permanent funding mechanism, Pinpoint has been allocated an amount up to for the 2016-2017 funding year. Pinpoint states that the funds will be used for peering point, Phase I/II site fees, maintenance, 911 fixed data costs, and text-to-911. Pinpoint has submitted estimates of the costs it expects to incur during the funding year in the amount of \$40,858.00. These costs are significantly greater than Pinpoint's allocation.

The Commission finds that the funding request for Pinpoint in the amount of up to \$6,959.00 should be approved. Amounts shall be paid no more than monthly in arrears based upon receipt of documentation filed by Pinpoint for expenses incurred.

Should Pinpoint find during the funding year additional uses not described in their annual application, it should submit an amended application request to include additional eligible expenses.

Pursuant to Docket 911-019/PI-118, expenses for which reimbursement is sought must have been incurred during the current funding year and must be consistent with the expenses identified in Pinpoint's application. Documentation supporting

eligible expenditures should be submitted by the 7th of the month in order to receive payment by the end of the month. Payment will be made no later than the end of the month following the receipt of the request, as long as proper documentation is received with the request in a timely manner.

Any wireless service provider failing to file timely and accurate quarterly reports may be subject to delays or loss of funding in addition to any other administrative penalties. All wireless service providers are subject to audit.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that the funding request for Pinpoint is hereby approved in the amount of up to \$6,959.00 paid in accordance with the terms set forth herein.

IT IS FURTHER ORDERED that Pinpoint request funds by filing documentation supporting eligible expenditures by the 7th of the month in order to receive payment by the end of the month.
