The Nebraska Public Service Commission opened the present docket on its own motion, seeking to investigate the requirements, costs and impact of the implementation of IP based Next Generation 911 (Next Gen 911) in Nebraska relating to the provision of Enhanced Wireless 911 Service.

Comments on multiple issues were filed by GeoComm, Qwest Corporation and TeleCommunications Systems, Inc. and NextGen Communications, Inc. d/b/a Maryland TeleCommunication System, Inc.
