"It is the intent of the Legislature to authorize the use of the Enhanced Wireless 911 Fund to fund a study of the implications, costs, and consideration of next-generation emergency telephone communications."

In order to ensure the independence and timeliness of the next-generation 911 study (Study), the Commission contracted with a project manager and independent third party contractor to conduct the study. "The independent third party shall submit an initial report to the commission not later than January 31, 2014."
