O P I N I O N A N D F I N D I N G S

The Nebraska Public Service Commission (Commission) hereby opens the above-captioned docket, on its own motion, to implement provisions of LB 938 [2016]¹ and to develop and prepare a plan for the 911 service system.

LB 938 requires that the Commission:

Be responsible for the statewide planning, implementation, coordination, funding assistance, deployment, and maintenance of the 911 service system to ensure that coordinated 911 service is provided to all residents of the state at a consistent level of service in a cost effective manner.²

Furthermore, the Commission is responsible for getting input from the public safety answering points, public safety agencies, originating service providers, municipal and county officials, and the Chief Information Officer.

The Statute requires the Commission hold at least two public hearings on the plan, one at least 90 days before adoption, and one at least 30 days before adoption.³ The first such hearing will be held Thursday, July 20, 2017, at 10:00 A.M., in hearing room 1524, Nebraska State Capitol, 1445 K Street, Lincoln, Nebraska.

This docket will be the vehicle for any filings or actions necessary related to the 911 Service System Plan.


