BY THE COMMISSION:

By written request for funding received December 2, 2002, Jefferson County, Fairbury, seeks funding from the Enhanced Wireless 911 Fund for expenses of implementing and providing enhanced wireless 911 service. Jefferson County has one public safety answering point (PSAP), which will provide enhanced wireless 911 service throughout Jefferson County. The local exchange carrier serving Jefferson County's PSAP is ALLTEL Nebraska, Inc. (ALLTEL). Jefferson County's PSAP is served by the following wireless carriers: ALLTEL and Western Wireless.

Jefferson County entered into a service agreement with ALLTEL for enhanced wireless 911 equipment and services. A copy of the agreement is attached to the request for funding. In the agreement, Jefferson County authorized the Nebraska Public Service Commission to remit all payments, including the charges of third-party database vendor Intrado, for enhanced wireless 911 service to ALLTEL.

Jefferson County seeks additional costs of \$25,600.00 and recurring costs of \$3,150.00 per month to implement and provide enhanced wireless 911 service for each of the above-listed wireless carriers. Initial costs are for database upgrades, trunking infrastructure and purchase, installation, and testing of circuits for enhanced wireless 911. Initial costs also include Intrado's charges for implementation of the entire ALLTEL service area. It is more efficient to price and implement Intrado's services for all PSAPs that will require it, rather than do so in a piecemeal fashion. Recurring costs are monthly fees for database management and for operation and maintenance of trunks and circuits, and also include Intrado's recurring charges for the entire ALLTEL service area.

O P I N I O N A N D F I N D I N G S

This request for funding is being processed pursuant to Neb. Rev. Stat. §§ 86-2201 to 86-2214. (2001 Supp.), 291 Neb. Admin. Code, Chapter 1, Section 5, and Progression Order No. 5 in Commission Docket No. 911-001, entered July 16, 2002.

Costs requested are eligible under Neb. Rev. Stat. § 86-2210 (2001 Supp.) All costs have been incurred or will be incurred for the purchase, installation, maintenance and operation of telecommunications equipment and telecommunications services required for the provision of enhanced wireless 911 service.

Jefferson County has submitted a PSAP registration in compliance with Commission Docket No. 911-001.

Because Jefferson County authorized ALLTEL to receive all payments on its behalf for wireless enhanced 911, the Commission finds that payment should be made to ALLTEL upon invoice. Only invoices that comport with the approved costs in this order will be paid. Recurring costs requested for partial months must be pro rated.

Based upon the request for funding and supporting documentation, the Commission is of the opinion and finds that the request for funding should be granted. All costs of Nebraska Universal Service Fund (NUSF) surcharges and any legitimate government-imposed taxes or surcharges assessed on enhanced wireless 911 charges should also be paid. The Commission further finds that Jefferson County should update its subscriber counts on a quarterly basis and that the Commission should adjust payments for non-recurring and recurring charges accordingly.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Jefferson County's request for funding shall be granted.

IT IS FURTHER ORDERED that upon invoice from ALLTEL, the Commission shall remit to ALLTEL amounts that comport with this order.

IT IS FURTHER ORDERED that any government-imposed taxes or surcharges assessed on enhanced wireless 911 charges shall be paid.

IT IS FURTHER ORDERED that Jefferson County provide to the Commission, updated subscriber counts on a quarterly basis, and that payments to Jefferson County shall be adjusted accordingly.
