BY THE COMMISSION:

On March 24, 2015, the Nebraska Public Service Commission (the "Commission") opened the above-captioned proceeding investigate the cost model used by the Federal Communications Commission ("FCC") for Connect America Fund ("CAF") support. In that Order, the Commission solicited comments on the threshold question of whether it should utilize Nebraska universal service fund monies to obtain access to the CostQuest Associates, Inc. ("CostOuest") State Broadband Cost Model ("SBCM") which, according to CostQuest, replicates the processing logic, inputs and reporting formats of the adopted FCC price cap model ("CACM"). Based on information provided to the Commission, a \$30,000 annual license fee would provide access to the CostQuest SBCM, with the ability to interact with various methods of the model and generate results as needed.

Comments responsive to the Commission's March 24, 2015 Order were filed by Qwest Corporation d/b/a CenturyLink QC and United Telephone Company of the West d/b/a CenturyLink; the Rural Independent Companies; and the Rural Telecommunications Coalition of Nebraska. CenturyLink filed comments in support of the Commission's effort to investigate the SBCM saying the "SBCM model will provide better information on what the cost of providing service should be." The Rural Independent Companies also recommended the Commission pursue a licensing agreement with CostQuest for this purpose responding "the Commission will be better enabled to determine the investment needed and expenses that will be incurred by telecommunications carriers providing service in rural areas of the State to build a robust infrastructure." The RTCN recommended against the Commission

expending the \$30,000 annually to acquire rights through a license to the SBCM.3

OPINION AND FINDINGS

As the Commission indicated in its March 24, 2015 Order opening this proceeding, it has not yet analyzed the SBCM, nor the CACM; and, therefore is not endorsing the use of either model or its inputs for calculating broadband network costs. However, the Commission finds having access to the SBCM/CACM may useful in relation to other matters currently under Commission consideration, including but not limited to the NUSF-99 and NUSF-100 proceedings. Accordingly, the Commission directs the staff to work with CostQuest to obtain a mutually agreeable licensing agreement where the Commission and interested parties would then be able to obtain access through these investigations.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that the findings and conclusions made herein be and they are hereby adopted.
