O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Buyers United International, Inc.; Corporate Calling Services, Inc.; Feist Long Distance; SeTel, L.L.C.; SmartStop, Inc.; 360° Long Distance, Inc.; Telegroup, Inc.; and World Call Telecommunications, Inc. have satisfied the filing requirements and should be, and are hereby, dismissed from the departmental complaint and need not appear at the October 19, 1999, hearing.

IT IS FURTHER ORDERED that a public hearing is set for October 19, 1999, at 1:30 p.m. in the Commission Hearing Room, 300 The Atrium, 1200 N Street, Lincoln, Nebraska. With the exception of USN Communications Long Distance, Inc. and Allnet Communications Services, Inc. d/b/a Frontier Communications Service, the above-mentioned defendants who have not been dismissed from this complaint are to appear before the Commission for the public hearing.
