O P I N I O N A N D F I N D I N G S

On June 4, 2013, the Commission entered an Order Sustaining the Show Cause in as it related to several companies named in the Show Cause Order. Among its findings, the Commission found Credit Union Wireless should be required to file its remittance audit and assessed an administrative penalty in the amount of \$3,300.

Subsequently, Credit Union Wireless requested reconsideration of the Commission's Order. In light of Credit Union Wireless's request for reconsideration, the mitigating circumstances provided by the company, and its commitment to file its remittance audit, the Commission hereby reconsiders the portion of its Order levying a \$3,300 administrative penalty.

The Commission finds the remittance audit should be filed no later than **September 16, 2013**. The Commission further finds the administrative penalty should be waived. However, the Commission cautions Credit Union Wireless that if the remittance audit is not timely filed, it will consider Credit Union Wireless to be in willful violation of a Commission Order and will re-instate the administrative penalty waived by this Order.

In all other respects, the Commission's June 4, 2013 Order Sustaining the Show Cause shall be in full force and effect.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that the June 4, 2013 Order to Show Cause shall be and it is hereby reconsidered in part, relative to Credit Union Wireless.

IT IS FURTHER ORDERED that Credit Union Wireless is hereby required to file its remittance audit with the Commission no later than **September 16, 2013**.
