O P I N I O N A N D F I N D I N G S

By Complaint dated March 31, 2009, Sue Vanicek, the Director of the Nebraska Telecommunications Infrastructure and Public Safety Department ("NTIPS") Department of the Nebraska Public Service Commission ("Commission") (hereinafter "Complainant") filed a Complaint against Cozac Wireless, LLC d/b/a Movida Communications (hereinafter "Respondent") alleging that Respondent failed to file the required remittance worksheets or remittance payments to the NTIPS Department by the 15th day following the end of the remittance period. A copy of the Complaint was mailed to the Respondent, by certified mail, on April 30, 2009. No answer was filed.

By Commission order, a hearing on this matter was scheduled for August 4, 2009, in conjunction with hearings for Docket Nos. 911-030.31 and 911-033.09. However, Commission staff is currently working with Respondent to settle any and all complaints.

Upon review of the matter, I am of the opinion and find that the hearing, previously scheduled for August 4, 2009, should be continued to **September 22, 2009 at 1:30p.m.** in the Commission Hearing Room, 300 the Atrium, 1200 N Street, Lincoln Nebraska. The hearing will be held in conjunction with hearings on Docket Nos. 911-033.09 and 911-030.31.
