OPINION AND FINDINGS

On August 31, 2004 Jeffrey L. Pursley, Director of the Nebraska Universal Service Fund (NUSF) Department of the Nebraska Public Service Commission (Commission) (hereinafter "Complainant") filed a Complaint against WorldxChange Corporation d/b/a Acceris Communications. (hereinafter "Respondent") alleging that Respondent failed to file the required remittance worksheets to the NUSF Department by the 15th day following the end of the remittance period for the $3^{\rm rd}$ and $4^{\rm th}$ Quarters of 2003 and $1^{\rm st}$ and $2^{\rm nd}$ Quarters of 2004.

A copy of the Complaint was mailed to the Respondent, by certified mail, on September 9, 2004. On February 1, 2005, the Commission entered an Order setting this matter for hearing. A hearing was held in the Commission Hearing Room, Lincoln, Nebraska on March 8, 2005 at 1:00 p.m. Shana Knutson entered an appearance on behalf of the Commission staff. The Respondent failed to enter an appearance. Mr. Pursley, Director of the NUSF Department testified and recommended the Commission impose an administrative penalty upon the Respondent for the violations listed in the Complaint and not answered by the Respondent. Commission counsel requested the Commission consider the gravity and severity of the offense along with the lack of the good faith shown by the Respondent in failing to appear and answer to the allegations.

Upon consideration of the arguments presented in this case the Commission finds Respondent has failed to resolve the delinquency with the NUSF Department. Respondent has violated Section 3.02 of the Nebraska Universal Service Fund Rules provided in Neb. Admin. Code Title 291, Chapter 10. In consideration thereof, the Commission is of the opinion and finds that the Complaint filed herein should be sustained and Respondent should be assessed a penalty in the amount of Five Hundred and Nine dollars and Fourteen cents (\$509.14) in administrative fines and should be required to pay a late handling fee in the amount of Three Hundred and Fifty dollars (\$350.00).

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that the Complaint filed against Respondent WorldxChange d/b/a Acceris Communications shall be and it is hereby sustained.

IT IS FURTHER ORDERED that Respondent pay an administrative fine in the amount of Five Hundred dollars and Nineteen cents (\$509.14) for the violations found herein.

IT IS FURTHER ORDERED that Respondent pay a late handling fee in the amount of One Hundred dollars (\$350.00).

IT IS FURTHER ORDERED that Respondent remit to the Nebraska Public Service Commission all adjudged penalties and fees within thirty (30) days from the date of this Order.
