BY THE COMMISSION:

On March 12, 2013, the Commission entered a Protective Order in the above-captioned proceeding to govern the use of all confidential information and documents produced by, or on behalf of, any party in this proceeding. The Commission hereby modifies the prior Protective Order, on its own motion, to permit the disclosure and use of confidential information and documents to certain persons by adding subpart g. to paragraph 4. as follows:

- g. Any individual who has marketing, pricing, product development, market analysis, market entry, or strategic planning responsibilities for any party to this proceeding shall be entitled to review confidential information subject to signing the nondisclosure agreement and will be strictly limited to use of such information solely in this proceeding, or for preparation of and conduct of any appeals or subsequent FCC filing arising directly from this proceeding.

In addition, the Nondisclosure Agreement attached as Exhibit "A" to the March 12, 2013 Protective Order should be replaced in its entirety by the Exhibit "A" attached to this Order. Any Nondisclosure Agreements which have already been executed by persons not covered by subpart (g) described above shall not be considered invalid due to the modifications made by this Order.

All other provisions of the Protective Order entered on March 12, 2013 shall remain in effect until specifically modified or terminated by the Commission.

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission in the above-captioned matter that this modification to the Protective Order be adopted.

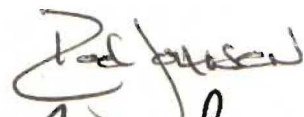
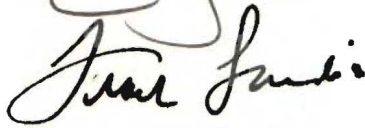

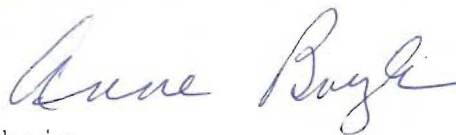
