OPINION AND FINDINGS

On February 23, 2010, pursuant to LB 1222 [2006], the Commission adopted the Wireless 911 Support Allocation Model (911-SAM) in this docket for the purpose of making disbursements from the Enhanced Wireless 911 Fund (the "E911 Fund") to eligible wireless service providers (WSPs) and public service answering points (PSAPs).

On April 4, 2018, the E911 Fund became the 911 Service System Fund upon passage of LB 993 [2018]. LB 993 also directed the Commission to:

- (a) Determine how to allocate the 911 Service System Fund in order to facilitate the planning, implementation, coordination, operation, management, and maintenance of the 911 service system;
- (b) Create a mechanism for determining the level of funding available to or for the benefit of local governing bodies, public safety answering points, and third-party service or infrastructure providers for costs determined to be eligible by the commission; and
- (c) Establish standards and criteria concerning disbursements from the 911 Service System Fund for the planning, implementation, coordination, operation, management, and maintenance of the 911 service system. 1

LB 993 also established the 911 Service System Advisory Committee, (Advisory Committee) to "make recommendations to the Commission regarding the exercise of the commission's duties administering the 911 Service System."²

On May 1, 2018, the Commission issued an Order in this docket finding that the 911-SAM is due for replacement.³ On April 1, 2020, the Advisory Committee, with the input of various stakeholders, including the Nebraska League of Municipalities, and the Nebraska Association of County Officials, adopted a proposal recommending a new method of allocating funding to the Nebraska 911 Service System. The Commission will consider this proposal under a separate docket.⁴

In the meantime, with respect to the 2020-2021 funding year, the Commission hereby determines that 911 funding allocated to PSAPs and WSPs shall be maintained at the same level as provided to such funding recipients during the 2019-2020 funding year. The only changes in funding allocation are an increase for Boone County and the elimination of funding to Nance County, reflecting the closure and consolidation of the Nance County PSAP into the Boone County PSAP. Therefore, funding for the 2020-2021 funding year is authorized for eligible PSAPs in a total amount of up to \$4,858,110.79 and for WSPs in an amount up to \$1,007,264.

Attached hereto and incorporated herein by this reference are Appendix A, a summary of the funding to each PSAP after all pre-existing commitments are paid for in the 2020-2021 funding year; and Appendix B, outlining WSP Support. In the event of a change in the number of PSAPs, due to consolidation or otherwise, during the 2020-2021 funding year, the Commission may consider adjustments to such allocations, via amendment to this Order.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that the Commission staff be authorized to make disbursements for the 2020-2021 funding year as described herein.
