BY THE COMMISSION:

On or about May 3, 2022, the Saline County Public Safety Answering Point ("PSAP") filed a request to use set aside funds to purchase Intellicomm Emergency Medical Dispatch ("EMD") software and guidecards from APCO, along with integration of EMD with Saline County's computer assisted dispatch ("CAD") system from CentralSquare, at a total cost of \$40,958.68.

The Enhanced Wireless 911 Advisory Board considered Saline County's funding request at a meeting held on May 18, 2022 and recommended that the request be approved.

O P I N I O N A N D F I N D I N G S

Pursuant to the 911 Service System Act¹ (the "Act"), the Public Service Commission is responsible for allocating funding to PSAPs from the 911 Service System Fund (the "Fund").² The Fund consists of 911 surcharges collected by wireless carriers from wireless service customers.³ The Act provides that money in the fund may be used to pay for costs that are determined by the Commission to be eligible for funding, including costs incurred by PSAPs for acquisition, installation, maintenance, and operation of telecommunications equipment and services required for the provision of 911 service.⁴

The Saline County PSAP has not yet connected to the next generation 911 emergency services IP network or core services, and

therefore operates under the legacy funding system.⁵ Legacy PSAPs may set aside up to seventy-five percent (75%) of their annual funding allocation for future purchases of equipment and software, if approved by the Commission. The purchases requested by Saline County are shared costs and subject to the county's wireless/wireline ratio for the current funding year, which is 92 percent.

Saline County's cost for the Intellicomm EMD system is \$34,100.22, which includes \$2,000.00 for first year maintenance and specialized training at a cost of \$2,883.00. The use of set-aside funds to pay for training costs is subject to an annual cap equal to five percent of the PSAP's annual funding allocation.⁶ In the case of Saline County, this equates to a maximum amount of \$3,174.87 for the 2021-2022 funding year, therefore the annual cap in training expenses will not result in any reduction of the amount of set-aside funds available to pay for training.

The CAD portion of the project is being shared equally among the PSAPs in Saline County, Seward County and York County. Saline County's share of the \$18,400.36 total cost of the CAD upgrades is \$6,133.46, plus \$725.12 for first year maintenance. After applying the wireless/wireline ratio of 92 percent to Saline County's total cost of \$40,958.80, the amount eligible to be paid out of set-aside funds is \$37,682.10.

Based upon the request for funding, supporting documentation, and in consideration of the recommendation of the Advisory Board, the Commission is of the opinion and finds that the costs requested are eligible for funding as costs incurred for the purchase, installation, maintenance or operation of telecommunications equipment and telecommunications services required for the provision of 911 service, plus allowable training expenses. Therefore, the Commission finds that use of set-aside funding by Saline County should be approved in an amount not to exceed **\$37,682.10**.
