OPINION AND FINDINGS

On March 30, 2004, the Commission entered an Order pursuant to the Enhanced Wireless 911 Services Act, Neb. Rev. Stat. §§ 86-442 through 86-469 (2002 Cum. Supp.) (the Act), establishing a policy outlining submissions required to be made by wireless carriers to the Commission on a quarterly basis.

The majority of the submissions required under the March 30, 2004 Order were previously required by each order granting an application for funding from a wireless carrier. However, in anticipation of the implementation of Phase II enhanced wireless 911 service, the Commission found that it was necessary to refine the required submittals from wireless carriers.

Pursuant to the March 30, 2004 order, the wireless carriers were required to file their submittals with the Commission quarterly on or before the 15th of the month following the close of a quarter. Based upon the schedule set forth in the March 30, 2004 order, the first submittals were due to the Commission on or before April 15, 2004.

AT&T Wireless PCS, LLC; Sprint; and ALLTEL each filed Motions for Extension of Time for submitting information pursuant to the March 30, 2004 order. AT&T and Sprint requested an extension until May 15, 2004. ALLTEL requested an extension until May 31, 2004.

After due consideration and being fully advised in the premises, the Commission is of the opinion and finds that the above-mentioned motions should be granted and each of the above-listed carriers should be granted an extension to make the required filing until May 31, 2004.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that the motions for extensions of time for submitting
