BY THE COMMISSION:

The Commission is responsible for administration of the Wireless Enhanced 911 Fund, pursuant to the Enhanced Wireless 911 Services Act (Act).¹

"Each wireless carrier who has a subscriber with a billing address in Nebraska shall collect a surcharge of not more than fifty cents per month per access line."² The surcharge is currently fifty cents and must be added "to each subscriber's billing statement" as "a separate line item charge" on the statement labeled "Enhanced Wireless 911 Surcharge".³

The Commission has been asked to clarify whether certain prepaid wireless providers are required to collect and remit the surcharge.

O P I N I O N A N D F I N D I N G S

The Enhanced Wireless 911 Services Act provides that "The Commission shall determine the most efficient method for providing enhanced wireless 911 service,"⁴ and further provides that "[t]he Commission shall have any powers necessary to carry out the intent and purposes of the Act."

Due to the complexity of the issue and possible effects for other carriers and on the Enhanced Wireless 911 Fund, the Commission finds that it should open a public investigation to explore the following issues:

- a. Whether prepaid wireless providers are required to collect and remit the Enhanced Wireless 911 Surcharge?
- b. How the prepaid wireless providers should collect the Enhanced Wireless 911 Surcharge from individuals purchasing their services?


