OPINION AND FINDINGS

The Nebraska Public Service Commission (Commission) hereby opens the above-captioned docket, on its own motion, to investigate issues related to the current state of landline and enhanced wireless 911 service and the means to ensure statewide access to landline 911 and enhanced wireless 911 service.

Legislative Resolution 143, introduced by Senator Baker, directed the Transportation and Telecommunications Committee to conduct an interim study on issues related to 911 service throughout Nebraska. These issues include but are not limited to:

- 1. The current status of landline 911 in each county;
- 2. The rate and use of the landline 911 surcharge in each county;
- 3. The current status of enhanced wireless 911 throughout the state;
- 4. Implementation of Phase I and Phase II enhanced wireless 911 in other states;
- 5. Reimbursement of the costs of wireless service providers;
- 6. Distribution of the wireless surcharge.
- 7. Consolidation of oversight of landline and wireless 911;
- 8. Consolidation of public safety answering points; and
- 9. Availability of federal funding, including homeland security funds, for projects in Nebraska.

The Commission requests written comment from all interested parties on issues related to 911 service in Nebraska on or before August 12, 2005, at 5:00 p.m. All parties filing comments should file one original, five paper copies and one electronic copy in MS Word format.
