BY THE COMMISSION:

On February 23, 2010, the Nebraska Public Service Commission (Commission) entered an order pursuant to Neb. Rev. Stat. § 86-465(1)(e) adopting a permanent funding mechanism and process to provide funding for the implementation and provision of enhanced 911 service. On April 28, 2015, the Commission entered an order authorizing payments to eligible public service answering points (PSAPs).

Due to a clerical error, the potential funding amount for three PSAPs in Appendix B was listed incorrectly. The Commission finds that an order nunc pro tunc should be entered to correct the potential funding amount listed in Appendix B for Boone, Nance, and Merrick counties. The Commission finds that Appendix B should be amended to correct the clerical error. Attached hereto and incorporated herein by this reference is a corrected copy of Appendix B, which shall replace the Appendix B attached and incorporated into the April 28, 2015 order.

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Appendix B attached to the April 28, 2015 order in the above-captioned matter is corrected to reflect the proper potential funding amount for Boone, Nance, and Merrick counties.
