On or about May 15, 2013 Sue Vanicek, Director of the Nebraska Telephone Infrastructure and Public Safety Department (Complainant), filed a complaint in this docket alleging a violation of Neb. Rev. Stat. § 86-437. Complainant alleged Respondents failed to timely file with the Commission annual reporting information as required by § 86-437(2) by April 30, 2013. Complainant sought an order assessing administrative fines and ordering Respondents to comply with the reporting requirements.

Certain Respondents will likely be dismissed from this complaint. However, a hearing will be necessary regarding any remaining Respondents.
