BY THE COMMISSION:

On or about May 13, 2014 Sue Vanicek, Director of the Nebraska Telephone Infrastructure and Public Safety Department (Complainant), filed a complaint in this docket alleging a violation of Neb. Rev. Stat. § 86-437. Complainant alleged Respondents failed to timely file with the Commission annual reporting information as required by § 86-437(2) by April 30, 2014. Complainant sought an order assessing administrative fines and ordering Respondents to comply with the reporting requirements.

Certain Respondents will likely be dismissed from this complaint. However, a hearing will be necessary regarding any remaining Respondents.

The Commission finds that a hearing on this matter, with respect to the remaining Respondents, should be scheduled on **July 29, 2014 at 1:30 p.m.** in the Commission Hearing Room, 300 The Atrium, 1200 'N' Street, Lincoln, Nebraska.


