BY THE COMMISSION:

The Commission opened the present docket on its own motion in order to investigate issues related to intertandem trunking across the State of Nebraska for use in provision of wireless enhanced 911 service. The Commission intended to require comment from the incumbent local exchange carriers. However, the order referred to Qwest, Alltel and Sprint. Due to recent transfers of control and name changes, the order should have required comment from Qwest Corporation, Windstream Nebraska, Inc., and United Telephone Company of the West d/b/a Embarq Corporation.

Therefore, the Commission finds that its July 11, 2006 order in the present docket should be amended to require comment on the issues listed therein from Qwest Corporation, Windstream Nebraska, Inc., and United Telephone Company of the West d/b/a Embarq Corporation.

Due to the fact that the order contained an error in the names of the proper parties, the Commission further finds that the deadline for comments should be extended. Therefore, Qwest Corporation, Windstream Nebraska, Inc., and United Telephone Company of the West d/b/a Embarq Corporation and any other interested parties shall file comments on the issues outlined in the July 11, 2006 order with the Commission **on or before August 25, 2006 at 5:00 p.m.** All parties filing comments should file one original and five paper copies and email one electronic copy to angela.melton@psc.ne.gov.
