#### BY THE HEARING OFFICER:

On or about February 29, 2008, NE Colorado Cellular, Inc., d/b/a Viaero Wireless (Viaero) filed an application for funding (Application) from the Enhanced Wireless 911 Fund. The Application was discussed at the Enhanced Wireless 911 Advisory Board (Advisory Board) meeting on April 21, 2008 at which time the Board determined that it needed additional information including detail regarding costs.

The Commission requested additional information on May 9, 2008. Viaero provided additional information on July 8, 2008 without the detailed cost information per county. The Application was discussed at the Advisory Board's July 14, 2008 meeting at which time Viaero provided the detailed cost information. The Board voted to request leave from the Commission to hold a special meeting in August for consideration of the Application and has not yet made a recommendation.

On July 23, 2008, Viaero filed a Motion to Schedule Hearing (Motion) on the Application. The Advisory Board's request for a special meeting was approved by the Commission on July 29, 2008. The meeting will be held on August 18, 2008.

Nothing prevents the Commission with proceeding to schedule a hearing on the Application prior to receiving a recommendation from the Advisory Board. The Hearing Officer finds that the Motion should be granted and a hearing on this matter should be scheduled for **September 24**, **2008 at 10:00 a.m.** in the Commission Hearing Room, 300 The Atrium, 1200 N Street, Lincoln. Such a schedule would grant the Advisory Board time to submit its recommendation prior to hearing on the matter.

Furthermore, prefiled testimony and exhibits should be filed no later than **5:00 p.m. on September 16, 2008.** Viaero should submit one (1) original and eight (8) copies and an electronic copy should be sent to angela.melton@psc.ne.gov.
