### BY THE COMMISSION:

By written request for funding received September 20, 2006, Clay County sought funding from the Enhanced Wireless 911 Fund for expenses of implementing and providing enhanced wireless 911 service related to Alltel Wireless. The local exchange carrier serving Clay County's PSAP is Windstream Nebraska, Inc.

Requests for funding were originally filed in Application Nos. PSAP-28, PSAP-GISD-026 and are now incorporated herein pursuant to the order entered on August 8, 2006 in Docket No. 911-023.

Clay County entered into a service agreement with Alltel for enhanced wireless 911 equipment and services. A copy of the agreement is attached to the original request for funding has been provided. In the agreement, Clay County authorized the Nebraska Public Service Commission to remit all payments for enhanced wireless 911 service to Alltel.

Clay County now seeks additional costs to implement and provide enhanced wireless 911 service described in Appendix A to this Order. These additional costs are for a new tower.

## OPINION AND FINDINGS

This request for additional funding is being processed pursuant to  $\underline{\text{Neb}}$ .  $\underline{\text{Rev}}$ .  $\underline{\text{Stat}}$ .  $\underline{\text{SS}}$  86-444 to 86-456. (2006 Cum. Supp.), 291 Neb. Admin. Code, Chapter 1, Section 5, and Progression Order No. 5 in Commission Docket No. 911-001, entered July 16, 2002.

Costs requested are eligible under Neb. Rev. Stat. § 86-465 (2004 Cum. Supp.) All costs have been incurred or will be incurred for the purchase, installation, maintenance and operation of telecommunications equipment and telecommunications services required for the provision of enhanced wireless 911 service.

Because Clay County has authorized Windstream to receive all payments on their behalf for wireless enhanced 911, the Commission finds that payment should be made to Windstream upon invoice. Only invoices that comport with the approved costs in this order will be paid. Recurring costs requested for partial months must be pro rated.

Based upon the request for funding and supporting documentation, the Commission is of the opinion and finds that the request for funding should be granted, effective July, 2006.

#### ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Clay County's request for additional funding shall be granted consistent with the terms set forth herein.

IT IS FURTHER ORDERED that the Commission shall remit to Windstream amounts that comport with Appendix A attached hereto once implementation is complete.

IT IS FURTHER ORDERED that Clay County is on notice and shall sign an acknowledgement indicating that Clay County is aware that approval of this funding request is made with the understanding that it may be modified in the future consistent with the permanent funding mechanism established pursuant to LB 1222 [2006].
