BY THE COMMISSION:

By written request for funding received January 15, 2009, Scottsbluff County, Gering, sought funding from the Enhanced Wireless 911 Fund for expenses for implementing and providing enhanced wireless 911 service totaling \$79,627.73 for an upgrade to its equipment necessary to implement enhanced wireless 911 service, and \$49,722.84 over three (3) years for maintenance.

On March 31, 2009, the Commission entered an order approving the application in part, in the amount of **\$29,835.51** in non-recurring costs representing fifty-five percent (55%) of the total upgrade cost minus certain optional equipment and **\$33,910.98** for maintenance representing sixty-eight percent (68%) of the request excluding that portion of the maintenance related to the optional equipment.

Pursuant to the terms of the Order, Scottsbluff County requested a hearing before the Commission regarding those portions of the funding request not approved.

Therefore, the Commission sets this matter for hearing on **May 6, 2009 at 10:00 a.m. CDT and 9:00 a.m. MDT** in the Commission Hearing Room, 300 The Atrium, 1200 N Street, Lincoln and via video conference at the Panhandle Research and Extension Center, High Plains Room, 4502 Avenue I, Scottsbluff, Nebraska.

Representatives from Scottsbluff County should be prepared to present evidence to the Commission in support of their request.


