BY THE COMMISSION:

By written request for funding received from Gage County, Public Safety Answering Point, Beatrice, seeks funding from the Enhanced Wireless 911 Fund (Fund) for implementing and providing enhanced wireless 911 service.

In its application, Gage County seeks non-recurring costs in the amount of \$18,700.00 for the purchase and installation of software necessary for enhanced wireless 911 service. Gage County has entered into a contract with GeoComm, Inc. (GeoComm) for the purchase, installation, training, and one-year maintenance of GeoLynx software and has provided a copy of the contract with its request for funding.

The Enhanced Wireless 911 Advisory Board considered Gage County's request at its March 23, 2007 meeting and recommended that the Commission approve payment in the amount of \$18,700.00. All amounts requested are consistent with GeoComm's response to the Commission's RFP.

OPINION AND FINDINGS

This request for additional funding is being processed pursuant to <u>Neb</u>. <u>Rev</u>. <u>Stat</u>. §§ 86-442 to 86-470. (Cum. Supp. 2006), 291 Neb. Admin. Code, Chapter 1, Section 5, Progression Order No. 5 in Commission Docket No. 911-001, entered July 16, 2002 and the Interim Policy established in Progression Order No. 1 in Commission Docket No. 911-017/PI-116, entered February 13, 2007 (Interim Policy).

Costs requested are eligible under $\underline{\text{Neb}}$. $\underline{\text{Rev}}$. $\underline{\text{Stat}}$. § 86-465 (2006 Supp.). All costs have been incurred or will be incurred for the provision of Phase II wireless enhanced 911 service.

The Commission finds that payment should be made to Gage County in the amount of \$18,700.00. Prior to receiving payment,

Gage County shall provide to the Commission sufficient documentation showing that payment has been made to GeoComm.

The Commission reserves the right to modify any costs associated with this funding request consistent with amendments to the Interim Policy or the establishment of a permanent funding mechanism.

If the Nebraska Legislature fails to appropriate or authorize the expenditure of sufficient funds to provide for the payment of costs from the Fund or, if a lawful order issued in or for any fiscal year during the term of the contract reduces the funds appropriated or authorized in such amounts as to preclude making the payments from the Fund, the Commission will not be responsible for any costs not reimbursed by the Fund.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that the request for funding of Gage County shall be granted.

IT IS FURTHER ORDERED that the Commission shall remit to Gage County from the Enhanced Wireless 911 Fund \$18,700.00 for non-recurring costs as described herein upon receipt by the Commission of proof of payment.
