BY THE COMMISSION:

By written request for funding received from Nance County, Public Safety Answering Point, Fullerton, seeks funding from the Enhanced Wireless 911 Fund (Fund) for implementing and providing enhanced wireless 911 service.

In its application, Nance County seeks non-recurring costs in the amount of \$16,000.00 for the purchase and installation of software necessary for enhanced wireless 911 service. Nance County has entered into a contract with GeoComm, Inc. (GeoComm) for the purchase, installation, training, and one-year maintenance of GeoLynx software and has provided a copy of the contract with its request for funding.

Additionally, Nance County seeks reimbursement of \$19,200.00 for expenses incurred for the development of GIS data.

The Enhanced Wireless 911 Advisory Board considered Nance County's request at its March 23, 2007 meeting and recommended that the Commission approve payments in the amount of \$16,000.00 and \$19,200.00. All amounts requested are consistent with GeoComm's response to the Commission's RFP.

OPINION AND FINDINGS

This request for additional funding is being processed pursuant to Neb. Rev. Stat. §§ 86-442 to 86-470. (Cum. Supp. 2006), 291 Neb. Admin. Code, Chapter 1, Section 5, Progression Order No. 5 in Commission Docket No. 911-001, entered July 16, 2002 and the Interim Policy established in Progression Order No. 1 in Commission Docket No. 911-017/PI-116, entered February 13, 2007 (Interim Policy).

Costs requested are eligible under $\underline{\text{Neb}}$. $\underline{\text{Rev}}$. $\underline{\text{Stat}}$. § 86-465 (2006 Supp.). All costs have been incurred or will be incurred for the provision of Phase II wireless enhanced 911 service.

The Commission finds that payment should be made to Nance County in the amount of \$16,000.00 for the GeoComm Map Display

software and an additional \$19,200.00 for initial GIS data development subject to the terms herein. Prior to receiving payment, Nance County shall provide verification that it has received the GIS data from GeoComm and that said data meets all specifications set forth in the RFP and includes all necessary map layers. Additionally, Nance County shall provide to the Commission sufficient documentation to show that payment to GeoComm has been made.

The Commission and its authorized staff shall have access to all GIS data developed. Additionally, agencies and political subdivisions of the State of Nebraska, to the extent allowed by law and by agreement of the parties, shall have access to data as deemed appropriate by the Commission. The data and all updates shall be provided for inclusion in the centralized GIS data repository.

The Commission reserves the right to modify any costs associated with this funding request consistent with amendments to the Interim Policy or the establishment of a permanent funding mechanism.

If the Nebraska Legislature fails to appropriate or authorize the expenditure of sufficient funds to provide for the payment of costs from the Fund or- if a lawful order issued in or for any fiscal year during the term of the contract reduces the funds appropriated or authorized in such amounts as to preclude making the payments from the Fund, the Commission will not be responsible for any costs not reimbursed by the Fund.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that the request for funding of Nance County shall be granted.

IT IS FURTHER ORDERED that the Commission shall remit to Nance County from the Enhanced Wireless 911 Fund \$16,000.00 for non-recurring costs as described herein upon receipt by the Commission of proof of payment.

IT IS FINALLY ORDERED that the Commission shall remit to Nance County from the Enhanced Wireless 911 Fund \$19,200.00 for initial GIS data development subject to the terms herein including receipt of proof of payment and written verification regarding the data.
