BY THE HEARING OFFICER:

By written request for funding dated January 19, 2009, Mid Rivers 911, Public Safety Answering Point, Campbell (Mid Rivers) seeks funding from the Enhanced Wireless 911 Fund (Fund) for implementing and providing enhanced wireless 911 service.

In its application, Mid Rivers seeks non-recurring costs in the amount of **\$140,852.00** for the purchase and installation of equipment necessary for enhanced wireless 911 service and costs in the amount of **\$16,826.00** paid in equal annual installments for four years equipment maintenance. Additionally, Mid Rivers seeks non recurring costs of **\$15,500.00** for the purchase and installation of mapping software and an additional **\$14,604.00** paid in equal annual installments for five (5) years software support.

Pursuant to Neb. Admin. Code, Title 291, Ch. 1, § 5, Progression Order No. 5 in Commission Docket No. 911-001, entered July 16, 2002 PSAPs must have all equipment needed to operate landline enhanced 911 and the capability to receive data prior to receiving funding. Mid Rivers has not satisfied these requirements. Therefore, the Hearing Officer finds that a hearing is necessary to determine whether said requirements should be waived.
