O P I N I O N A N D F I N D I N G S

On or about August 8, 2006, the Nebraska Public Service Commission (Commission) opened the above-captioned docket, on its own motion, to develop policies and process requests for access to GIS data and the GIS Repository.

In an order entered on August 30, 2005 in docket No. 911-011/PI-97, the Commission approved the development of proper GIS data and map databases for public safety answering points (PSAPs) or supplementation of existing map databases necessary for Phase II service.

On April 4, 2006, the Commission also approved funding for a centralized data repository (Repository) for the GIS data, in order to allow for maintenance of the data and access to the data by individual PSAPs and the Commission.

On October 10, 2007, the Commission approved a GIS Data Repository Access and Use Policy and a procedure for entities to request access to the Repository.

On or about March 31, 2010, Columbus Police Department submitted an application requesting access to the Repository for 911 purposes. On April 13, 2010 their application for access to the GIS Repository granted. On May 12, 2014, Columbus Police Department requested that their access be amended to include data from Antelope, Boone, Butler, Cass, Colfax, Dodge, Douglas, Greeley, Hall, Hamilton, Howard, Lancaster, Madison, Merrick, Nance, Platte, Polk, Sarpy, Saunders, Seward, Stanton, Wheeler, and York counties.

The Commission finds that the request should be granted and Columbus Police Department's access be amended to include data from Antelope, Boone, Butler, Cass, Colfax, Dodge, Douglas, Greeley, Hall, Hamilton, Howard, Lancaster, Madison, Merrick, Nance, Platte, Polk, Sarpy, Saunders, Seward, Stanton, Wheeler, and York counties.

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Columbus Police Department's application for amended access to the GIS Repository is granted.

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Columbus Police Department's application for amended access to the GIS Repository is granted.


