## BY THE HEARING OFFICER:

Upon the complaint of Sue Vanicek, Director of the Nebraska Telecommunications Infrastructure and Public Safety Department of the Nebraska Public Service Commission, (Complainant), Cozac Wireless, LLC d/b/a Movida Communications, Kansas City, Missouri (Respondent) is alleged to be in violation of Neb. Rev. Stat. § 86-459(2) as outlined in the departmental complaint. A copy of the complaint was served on Respondent via certified mail on May 13, 2009. The Complaint alleges Respondent violated § 86-459(2) when it failed to file with the Commission the required report(s) due April 15, 2009 for the first quarter 2009 and seeks administrative fines and costs. To date no Answer has been filed.
