O P I N I O N A N D F I N D I N G S

On or about March 30, 2010, the Nebraska Public Service Commission (Commission) opened the above-mentioned docket, on its own motion, seeking to administer funding for public safety answering points for the implementation and provision of Enhanced Wireless 911 service pursuant to the permanent funding mechanism.¹

The City of South Sioux City (South Sioux City) began receiving interim funding in the amount of \$45,976.49 for the 2012-13 funding year. This amount reflects a deduction in the amount of \$3,941.00 for pre-existing commitments. Interim payments were made with the understanding that any adjustments made as a result of issues being considered in Docket No. 911-019/PI-118² would be retroactive to July 1, 2012.

On September 18, 2012, the Commission entered an order in Docket No. 911-019/PI-118 resolving the outstanding issues resulting in adjustments to PSAP funding.³ Based upon those adjustments and the modification of certain pre-existing payments for some PSAPs, the Commission finds that South Sioux City is approved for a total funding amount of \$80,544.68 for the 2012-2013 funding year. An adjustment was made in the amount of \$8,359.36 to account for amounts already received for the current




IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that the funding for South Sioux City is hereby adjusted as set forth herein.


