OPINION AND FINDINGS

On or about March 30, 2010, the Nebraska Public Service Commission (Commission) opened the above-mentioned docket, on its own motion, seeking to administer funding for public safety answering points for the implementation and provision of Enhanced Wireless 911 service pursuant to the permanent funding mechanism approved under Docket No. 911-019/PI-118.

On April 4, 2011, the City of Grand Island (Grand Island) filed its application for funding with the Commission pursuant to Docket No. 911-019/PI-118.

Grand Island, which provides service to Hall County, is eligible for funding in the amount of \$94,519.82 for the 2011-12 funding year. Grand Island has indicated that it anticipates using the funding provided for the following purposes: pictometry GIS data, 911 trunk lines, 911 system annual maintenance, CAD services contract, E911 CAD interface, small equipment purchases and/or repair, Geolynx upgrade, and training, and plans to set aside 9% of its funding for future equipment and software upgrades and purchases.

In its application, Grand Island stated that it planned to use its funding to cover costs associated with language translation services for non-English speaking 911 callers. Based upon the face of the application and additional information provided, it appears that the services to be provided are done so pursuant to a personnel services contract constituting personnel costs and therefore ineligible for funding. This service was also listed among the planned uses of funding for Grand Island's 2010-2011 funding request approved June 15, 2010, and should also have been considered ineligible for funding at that time. Should Grand Island wish to have an opportunity to present evidence before the Commission as to why the costs associated with the contract should be considered eligible for funding, Grand Island may request

within 30 days from the date of this order that the Commission set the matter for hearing.

Prior funding commitments in the amount of \$4,851.00 were previously approved and must be deducted from the allocation.

Based upon the above, the Commission finds that the funding request for Grand Island in the amount of \$89,668.82, should be approved consistent with the allocation determined in Docket 911-019/PI-118.

Pursuant to Docket 911-019/PI-118, Grand Island is required to submit documentation to justify expenditures, including an accounting of funds set aside for future equipment and software purchases, and update contact and other information no later than October 15 following the close of the funding year. If the Commission determines that any funds were not used appropriately, funding for the following funding year will be adjusted to recoup any necessary funds. All PSAPs are subject to audit.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that the funding request for the City of Grand Island is hereby approved as set forth herein in the amount of \$89,668.82.

IT IS FURTHER ORDERED that Grand Island submit required documentation to justify all expenditures with approved funds no later than October 15 following the close of the funding year consistent with the terms of the order approving the permanent funding mechanism and process in Docket 911-019/PI-118 entered on February 23, 2010.
