On or about March 30, 2010, the Nebraska Public Service Commission (Commission) opened the above-mentioned docket, on its own motion, seeking to administer funding for public safety answering points for the implementation and provision of Enhanced Wireless 911 service pursuant to the permanent funding mechanism approved under Docket No. 911-019/PI-118.

On April 1, 2016, Buffalo County filed its application for funding with the Commission pursuant to Docket No. 911-019/PI-118. Buffalo County, which serves Buffalo County, is eligible for funding in the amount of up to **\$105,320.13** for the 2016-17 funding year.

Buffalo County has indicated that it anticipates using the funding provided for 911 trunk lines, 911 system maintenance, 911 phone bill, GIS maintenance contract, equipment upgrades, Viper 911 upgrade, recurring maintenance, salaries, training, training expenses, mapping software, CAD maintenance, translation services, and plans to set aside 20% for future equipment, software upgrades and purchases.

No prior funding commitments exist.

Based upon the above, the Commission finds that the funding request for Buffalo County in the amount of up to \$105,320.13 should be approved consistent with the allocation determined in Docket 911-019/PI-118 paid in monthly installments of \$9,574.56 over eleven months.

Pursuant to Docket 911-019/PI-118, Buffalo County is required to submit documentation to justify expenditures, including an accounting of funds set aside for future equipment and software

purchases, and update contact and other information no later than October 15, following the close of the funding year. If the Commission determines that any funds were not used appropriately, funding for the following funding year will be adjusted to recoup any necessary funds. All PSAPs are subject to audit.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that the funding request for Buffalo County is hereby approved as set forth herein in the amount of up to **\$105,320.13**.

IT IS FURTHER ORDERED that Buffalo County submit required documentation to justify all expenditures with approved funds no later than October 15, following the close of the funding year consistent with the terms of the order approving the permanent funding mechanism and process in Docket 911-019/PI-118 entered on February 23, 2010.
