O P I N I O N       A N D       F I N D I N G S

On or about March 30, 2010, the Nebraska Public Service Commission (Commission) opened the above-mentioned docket, on its own motion, seeking to administer funding for public safety answering points for the implementation and provision of Enhanced Wireless 911 service pursuant to the permanent funding mechanism approved under Docket No. 911-019/PI-118.

On April 15, 2011, the City of Holdrege (Holdrege) filed its application for funding with the Commission pursuant to Docket No. 911-019/PI-118.

Holdrege, which provides service for Harlan and Phelps Counties, is eligible for funding in the amount of \$37,922.60 for the 2011-12 funding year. Holdrege has indicated that it anticipates using the funding provided for the following purposes: recording system costs, 911 backup system, E-911 2 wire voice grade circuits, E-911 telephone for internet services, 911 exchange haul to Great Plains, and two special access lines, and plans to set aside the remainder of its funding for future equipment and software upgrades and purchases.

Prior funding commitments in the amount of \$3,413.00 were previously approved and must be deducted from the allocation.

Based upon the above, the Commission finds that the funding request for Holdrege in the amount of \$34,509.60, should be approved consistent with the allocation determined in Docket 911-019/PI-118.

Pursuant to Docket 911-019/PI-118, Holdrege is required to submit documentation to justify expenditures, including an accounting of funds set aside for future equipment and software purchases, and update contact and other information no later than October 15 following the close of the funding year. If the


