O P I N I O N A N D F I N D I N G S

On or about March 30, 2010, the Nebraska Public Service Commission (Commission) opened the above-mentioned docket, on its own motion, seeking to administer funding for public safety answering points for the implementation and provision of Enhanced Wireless 911 service pursuant to the permanent funding mechanism approved under Docket No. 911-019/PI-118.

On March 31, 2016, Cheyenne County filed its application for funding with the Commission pursuant to Docket No. 911-019/PI-118. On May 3, 2016, the Commission entered its order authorizing all PSAP funding for the state based upon the calculations using the 911-SAM approved by the Commission February 23, 2010. Appendix A to the May 3, 2016 order indicates that Cheyenne County qualified for \$57,148.95.¹

Subsequent to the May 3, 2016 Order, the Commission completed an audit for the 2013-2014 funding year. The audit determined that Cheyenne County had set-aside \$5,325.62 in excess of the maximum 75% of funding that PSAPs are allowed to retain for future equipment and software purchases.² Therefore, pursuant to Commission Order, an adjustment was made to reduce Cheyenne County's annual funding in an amount equal to such excess and funding commitment, resulting in

funding to Cheyenne County for the 2016-2017 funding year in the amount of \$51,823.33.³

The Commission recently completed a review and audit of Cheyenne County for the 2012-2013, 2013-2014, 2014-2015 and 2015-2016 funding years. During such review, it was determined that personnel expenses for dispatchers who receive and process wireless enhanced 911 calls had not been included in the total of the County's expenditures for eligible expenses in the 2013-2014 funding year. However, PSAP costs eligible for wireless enhanced funding had been expanded to include such personnel expenses by Commission Order dated April 17, 2012.⁴

It is apparent that Cheyenne County incurred eligible personnel expenses exceeding \$5,325.62 for dispatchers who receive and process wireless enhanced 911 calls during the 2013-201 funding year. The fact that such eligible expenses were incurred by the PSAP eliminates the need for the adjustment described above.

Based on the foregoing, the Commission finds that funding for Cheyenne County should be modified to increase such funding by an amount equal to \$5,325.62 for the 2016-2017 funding year. Such amount shall be payable to Cheyenne County as an additional payment prior to the end of the 2016-2017 funding year.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that funding for Cheyenne County is hereby modified by increasing such amount by **\$5,325.62** as set forth herein, resulting in a total of up to \$57148.95 for the 2016-2017 funding year. Such additional amount shall be payable to Cheyenne County no later than June 30, 2017.
