BY THE COMMISSION:

On or about December 5, 2012, Cheyenne County filed a request for funding to upgrade existing Phase II 911 equipment and software at a cost of \$61,593.77. Cheyenne County is requesting that it be permitted to use its set aside funding in the amount of **\$52,970.64**, representing 86% of the total costs based upon wireless call volumes.

O P I N I O N A N D F I N D I N G S

The Nebraska Public Service Commission (Commission) adopted the permanent cost model to administer funding for public safety answering points for the implementation and provision of Enhanced Wireless 911 service under Docket No. 911-019/PI-118.

Based upon the request for funding and supporting documentation, the Commission is of the opinion and finds that a portion of the costs requested are eligible under Neb. Rev. Stat. § 86-465 as costs have been incurred or will be incurred for the purchase, installation, maintenance or operation of telecommunications equipment and telecommunications services required for the provision of enhanced wireless 911 service.

Pursuant to the permanent funding mechanism, PSAPs are permitted to retain up to seventy-five percent (75%) of the amount allocated to that PSAP for the future purchase of equipment and software.

Based upon the above, the Commission finds that funding request for Cheyenne County should be approved in the amount of **\$52,970.64**.

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that the request to use set aside funds filed by Cheyenne County is hereby approved as set forth herein in the amount of **\$52,970.64**, representing 86% of the total costs based upon wireless call volumes.
