BY THE COMMISSION:

On or about September 19, 2017, Cuming County filed a request to use set aside funds for the purchase of Computer Assisted Dispatch equipment from Justice Data Solutions for the Cuming County public safety answering point (PSAP) in the total amount of \$12,000.00.

Such costs are shared costs subject to the wireless/wireline ratio. The wireless ratio for Cuming County for the 2017-2018 funding year is 91% wireless.

The Wireless Enhanced 911 Advisory Board considered the request at its October 23, 2017 meeting, recommending the request be approved.

O P I N I O N   A N D   F I N D I N G S

The Nebraska Public Service Commission (Commission) adopted the permanent cost model to administer funding for public safety answering points for the implementation and provision of Enhanced Wireless 911 service under Docket No. 911-019/PI-118.<sup>1</sup>

PSAP costs related to Computer Aided Dispatch are eligible for funding pursuant to Docket No. 911-019/PI-118.<sup>2</sup> The amount eligible for funding using set-aside funds would be up to \$10,920.00 when utilizing the wireless ratio on file with the Commission.

Based upon the request for funding, supporting documentation, and in consideration of the recommendation of the Advisory Board, the Commission is of the opinion and finds that the costs requested are eligible under NEB. REV. STAT. § 86-465 as costs have

been incurred or will be incurred for the purchase, installation, maintenance or operation of telecommunications equipment and telecommunications services required for the provision of enhanced wireless 911 service.

Based upon the above, the Commission finds that use of set-aside funding by Cuming County should be approved in the amount of up to **\$10,920.00**.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that funding for Cuming County is hereby approved in the amount of up to **\$10,920.00**.
