On October 4, 2013, the City of Columbus, and Boone, Butler, Merrick, Nance, Polk, and Saunders Counties (Applicants) filed applications to use set aside funds for the purchase of new equipment and a seven (7) year maintenance plan as part of a joint project for the east central region at a total cost of \$1,043,637.00. Additionally, four of the seven PSAPs seek approval for advances of funding in varying amounts.

The Enhanced Wireless 911 Advisory Board considered the request at its October 21, 2013 meeting and recommended that the Commission approve the use of funds and advances.

The Commission finds that a hearing on these requests should be held jointly with all Applicants and a consolidated record. Therefore, hearing on this matter is set for **December 3, 2013 at 1:30 p.m.** immediately following the hearing currently scheduled on Docket No. 911-055/PI-182 in the Commission Hearing Room, 300 The Atrium, 1200 N Street, Lincoln, Nebraska.
