O P I N I O N A N D F I N D I N G S

On or about March 30, 2010, the Nebraska Public Service Commission (Commission) opened the above-mentioned docket, on its own motion, seeking to administer funding for public safety answering points for the implementation and provision of Enhanced Wireless 911 service pursuant to the permanent funding mechanism.¹

On April 12, 2012, Perkins County filed its application for funding with the Commission pursuant to Neb. Admin. Code Title 291, Ch. 15 § 007.01. Perkins County serves Perkins County.

Pending resolution of the issues currently being considered in Docket No. 911-019/PI-118², Perkins County is eligible for interim funding in the amount of \$16,336.50 for the 2012-13 funding year. This amount reflects a deduction for pre-existing commitments in the amount of \$8,747.95. Perkins County has indicated that it anticipates using the funding provided for the following purposes: GIS contract, maintenance contracts for hardware and software, trunking, and 911 recorder maintenance. The county plans to set aside 40% of its funding for future equipment and software upgrades and purchases.

Based upon the above, the Commission finds \$16,336.50 should be approved consistent with the allocation previously approved by the Commission in Application No. 911-019/PI-118³. Perkins County

shall receive monthly payments in the amount of \$1,485.14 until issues currently pending in Application No. 911-019/PI-118 are resolved and the allocations are recalculated.

Once a final decision is made regarding modifications to the model and allocations for the 2012-13 funding year, the Commission will true-up funding amounts for PSAPs including but not limited to making any adjustments for pre-existing commitments that may have expired or otherwise changed, for any adjustments necessary based upon the audit for the 2010-11 funding year, deductions from funding for any late filed applications, and for any change in allocation resulting from the addition of the personnel cost module. All true-ups will be made retroactively to July 1, 2012.

Perkins County is required to submit documentation to justify expenditures, including an accounting of funds set aside for future equipment and software purchases, and update contact and other information no later than October 15 following the close of the funding year consistent with Neb. Admin. Code, Title 291, Ch. 15 § 008. If the Commission determines that any funds were not used appropriately, funding for the following funding year will be adjusted to recoup any necessary funds. All PSAPs are subject to audit.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that the funding request for the Perkins County is hereby approved as set forth herein.

IT IS FURTHER ORDERED that Perkins County must submit required documentation to justify all expenditures with approved funds no later than October 15 following the close of the funding year consistent with Neb. Admin. Code, Title 291, Ch. 15 § 008.

All PSAPs are subject to audit.

IT IS FURTHER ORDERED that Perkins County must submit required documentation to justify all expenditures with approved funds no later than October 15 following the close of the funding year consistent with Neb. Admin. Code, Title 291, Ch. 15 § 008.
