OPINION AND FINDINGS

On or about March 30, 2010, the Nebraska Public Service Commission (Commission) opened the above-mentioned docket, on its own motion, seeking to administer funding for public safety answering points for the implementation and provision of Enhanced Wireless 911 service pursuant to the permanent funding mechanism approved under Docket No. 911-019/PI-118.

On April 15, 2010, the Frontier County Sheriff's Office (Frontier County) filed its application for funding with the Commission pursuant to Docket No. 911-019/PI-118.

Frontier County, which services the areas of Frontier County, is eligible for funding in the amount of \$23,420.77 for the 2010-11 funding year. Frontier County has indicated that it anticipates using the funding provided for the following purposes: maintenance agreements and costs, equipment repairs, training, software updates, GIS and other expenses incurred while furnishing E-911 wireless services, and plans to set aside up to seventy-five percent (75%) of its funding for future equipment and software upgrades and purchases.

Prior funding commitments in the amount of \$1,375.00 were previously approved and must be deducted from the allocation.

Based upon the above, the Commission finds that funding request for Frontier County in the amount of \$22,045.77 should be approved consistent with the allocation determined in Docket 911-019/PI-118.

Pursuant to Docket 911-019/PI-118, Frontier County is required to submit documentation to justify expenditures, including an accounting of funds set aside for future equipment and software purchases, and update contact and other information no later than October 15 following the close of the funding year.

If the Commission determines that any funds were not used appropriately, funding for the following funding year will be adjusted to recoup any necessary funds. All PSAPs are subject to audit.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that the funding request for the Frontier County Sheriff's Office is hereby approved as set forth herein in the amount of \$22,045.77.

IT IS FURTHER ORDERED that Frontier County submit required documentation to justify all expenditures with approved funds no later than October 15 following the close of the funding year consistent with the terms of the order approving the permanent funding mechanism and process in Docket 911-019/PI-118 entered on February 23, 2010.
