OPINION AND FINDINGS

On or about March 30, 2010, the Nebraska Public Service Commission (Commission) opened the above-mentioned docket, on its own motion, seeking to administer funding for public safety answering points for the implementation and provision of Enhanced Wireless 911 service pursuant to the permanent funding mechanism approved under Docket No. 911-019/PI-118.

On April 9, 2013, Thurston County filed its application for funding with the Commission pursuant to Docket No. 911-019/PI-118. Thurston County serves Thurston County. Thurston County is eligible for funding in the amount of up to \$44,863.74 for the 2013-14 funding year.

Thurston County has indicated that it anticipates using the funding provided for costs related to maintenance contracts and new equipment, and plans to set aside any remainder of its funding for future equipment and software upgrades and purchase.

No prior funding commitments exist.

Based upon the above, the Commission finds that the funding request for Thurston County in the amount of up to \$44,863.74, should be approved consistent with the allocation determined in Docket 911-019/PI-118 paid in monthly installments of \$4,078.52 over eleven months.

Thurston Pursuant to Docket 911-019/PI-118, County justify submit documentation to required expenditures, including an accounting of funds set aside for future equipment and software purchases, and update contact and other information no later than October 15 following the close of the funding year. the Commission determines that any funds were not used appropriately, funding for the following funding year will be

adjusted to recoup any necessary funds. All PSAPs are subject to audit.
